# WHAT IS ELDER ABUSE AND WHAT ARE THE SIGNS?

Elder abuse refers to any form of mistreatment of an older person, including physical, emotional, sexual, or financial abuse, as well as neglect and abandonment.

Some signs of elder abuse include:

**Physical signs:** bruises, broken bones, bed sores, or other injuries that are not adequately explained

**Emotional signs:** withdrawn behavior, depression, anxiety, or sudden changes in mood or behavior

Financial signs: sudden changes in bank account or banking practices, unexpected disappearance of funds or valuable possessions, and forged signatures on checks or legal documents

**Neglect:** untreated medical conditions, unsanitary living conditions, dehydration, malnutrition, or untreated bedsores

**Signs of isolation:** the older person is being prevented from seeing friends or family, or is being prevented from accessing medical care or services.

### TIPS TO PREVENT SCAMS

### **Guard Your Personal Information:**

Never share sensitive information like your social security number, bank details, credit card number, or Medicare information over the phone, unless you initiated the call and are certain of the recipient's identity.

### **Exercise Caution with Money Requests:**

Be cautious when strangers or even family members ask for money. Telemarketing scams targeting seniors can be incredibly deceptive, often preying on your kindness and generosity by posing as charities, organizations, or even relatives.

### **Avoid Gift Card Payments:**

Never pay anyone with gift cards. Whether it's a supposed government representative or a business associate, legitimate entities won't ask for payment in gift cards. This is a common tactic used by scammers.

### Do Not Hesitate to Hang Up:

If something feels off during a phone call, don't hesitate to hang up. Trust your instincts. Scammers often use high-pressure tactics or create a sense of urgency to manipulate their victims. Remember, it's okay to end the call if you feel uncomfortable or suspicious.

By staying vigilant and following these tips, you can better safeguard yourself against scams and protect your financial well-being.
